### Final conference of the CONSCIOUS project

Wednesday 16th December 2020 - online

The Conscious project is co-funded by the Rights, Equality and Citizenship Program of the European Commission. The project is conducted by the Department of Mental Health and Addiction Diseases of the ASL Frosinone, in partnership with the Guarantor of Detainees of Lazio, the European Network for the Work with Perpetrators of Domestic Violence and with the National Center for Studies and Research on Family and Minors' Law. CONSCIOUS aims to combat genderbased violence by reducing the risk of recidivism of perpetrators of domestic violence and sex offenders.

The focus of the project, which started in October 2018, was the experimentation of an intersystem cooperation network, since no institution or body can effectively implement a violence-prevention policy on its own. There was a focus on the involvement and responsibility of health institutions in gender-based violence interventions. This was promoted through the implementation of treatments aimed at reducing relapses, based on emotional regulation and the control of impulsiveness. Therefore, the interest of the actors involved was not only to guarantee specialised treatments for the perpetrators of sexual and gender-based violence, but also to define and consolidate the joint work of public institutions and bodies, as well as the private social sector and civil society.

The CONSCIOUS network encompasses all parts of the system: Health Administration (professionals and governance), Penitentiary Administration (through individual Institutes, Central Administration Probation System), and the Justice System (with lawyers and the judiciary) as well as the wider community, with the network of associations and non-profit organizations. The multidisciplinary network, necessary for the effective functioning of the model under experimentation, is made up of key stakeholders.

The objectives of the final event:

- -to illustrate the model of intervention, the results obtained and the lessons learned;
- -to contribute to the development and dissemination of an intersystemic approach which summarises the various approaches and methodologies;
- -to integrate the clinical, criminological, socio-educational points of view when setting up programs to prevent recidivism and violent behaviours;
- -to stimulate the debate between regional and national governments, prison and health institutions, professionals and the non-profit network.

During the event it will be possible to interact with the speakers through the chat, which will collect the questions that will be selected for the **final exchange and discussion session.**
