Institute of Violence Prevention hosting this year's Annual Workshop

The *Institute of Violence Prevention* works to prevent domestic violence by means of establishing conditions for perpetrators to change their behaviour as well as through prophylactic and educational work.

The *Institute of Violence Prevention* operates as small company and its team consists of professionals in the field of domestic violence: perpetrators programme facilitators, supervisors in the field of domestic violence, psychotherapist, probation officer and lawer.

The activity of the Institute was initiated by Marek Prejzner in 2001, while introducing the concept and practice of programmes for perpetrators of domestic violence in Poland, which were based on the American experiences of Duluth Programmes. Trainings, seminars, lectures and consultancy on methods of work with perpetrators, based in practice, resulted in development of first Polish programmes dedicated to domestic violance perpetrators.

The *Institute of Violence Prevention* conducts training courses for perpetrator programme facilitators and different types of public institution's workers who work with perpetrators of domestic violence, including: Social Services Institutions, Court and Prison Officers, Police, Regional Social Policy Council, District Family Support Centres, Crisis Intervention Centres as well as other social protection and inclusion units.

The team of the *Institute of Violence Prevention* established in 2015 the *Foundation Dialogue Without Violence* to support and develop the perpetrators programmmes led in the cooperation with public institutions.

<u>Association Centro di Ascolto Uomini Maltrattanti (CAM) hosting</u> <u>WWP-EN 2016 Study visit in Florence.</u>

Study visits are becoming a yearly tradition at WWP-EN. Every year an organization proposes a topic and an occasion to visit an organization working in the field of perpetrator programms as well as a space for exchange of practice and making new connections and sense of commuty.

This years Study visist will be hosted by Association Centro di Ascolto Uomini Maltrattanti (C.A.M.) in Florence. The organization is a founding member of WWP and started it's activity in 2009 as the first

perpetrator programme in Italy. Its principle activities are in the area of social assistance, social and health related issues, in the area of training and in the promotion of civil rights. In particular its main focus of activity is in the area of contrast and intervention and preventions of themes of violence against women and children promoting programs of change for men that are violent in interpersonal relationships, with a specific interest in fathering. The Association promotes this programs with the aim of eliminating male violence against women and children and to ensure victim safety and promoting social change. Since 2010 the Tuscan Region has supported an innovative model for E.R. intervention on domestic violence. This started initially in the hospital of city of Grosseto and data on screening for violence shooted from 15 cases in 2009 to 466 in 2010 after having started the "Rose Code" protocol. From an initial experimental project, the Tuscan Region has now extended this model to all of the hospitals throughout the Region. The name of the project is "Rose Code" and it encompasses a protocol among various Institutions (law enforcement, Judicial system, Women' Centers, Social services and recently perpetrator programs) to sustain all victims of violence that pass through the E.R. There has been some rather animated debate on the issue of focusing not only on gender violence, but at the moment the legal definition has been used and it encompasses all types of victims (children, elderly etc.). In August 2016 parlament passed a bill that confirms the intention to extend "Rose Code" procedures to all of the country. There has been a lively debate on issues of women's agency in pressing charges and legal requirments of the public health care system. In our study visit we will focus on screening for violence in the health care system and illustrating and visiting the "Rose Code" in Florence. We will highlight some of the contradiction of this system echoing Instambul Convention ambivalencies.

We will also present an overview of the global italian system and of the model that we are using with incoming men in terms of group work.

providers ourselves, we will take a closer look at the practice of perpetrators program functioning in Germany and at the recommendations based on Jyvaskyla model; we will consider basic risk and threat assestment. And this is only a part of the agenda.

In the evening of the second day of the conference we will be socializing and dining together in the old city center, just next to the charming main square. And significant part of participants takes advantage of being in Krakow not only to enjoy the Annual Workshop but as well to enjoy this beatiful city, staying longer for a day or two. We are happy to inform that after closing application process it is clear that we've got almost 90 applications registered and more than 80 participants attending. This will be for sure the Annual Workshop to remember!

Study Visit

The Study Visit 2016 will take place in Florence Italy from the 7th to the 9th of November. During the meeting, the small group of 8 participants will get acquainted with the experiences of the Centro Ascolto Uomini Maltrattanti (C.A.M.) for their work with perpetrators. We are looking forward to an inspiring and informative meeting.
