We are pleased to announce that registration is now open for our 2017 Annual Workshop, to be held in Zagreb, Croatia. Work with Perpetrators: Strengthening Accountability, Developing Practice and Increasing Safety - WWP EN Annual Workshop, Zagreb, Croatia, October 11 – 13, 2017

This will be our sixth annual meeting as a network, and we look forward to seeing you there.

Call for Workshops and Panels from WWP EN Members

We are also putting out a call for member organisations to nominate people who are interested in running workshops or being on panel sessions.

We will be focussing on 1 issue each day of the meeting, as follows -

Day 1: Strengthening Accountability - this may mean any of the following: accountability of the men on the programme, of the workers, of the programme, of the systems around the programme or of the perpetrator sector to the women's sector.

• 1 panel session and 4 workshops

Day 2: Developing Practice - the workshops that should be practice-based, we would like you to get participants to do all or part of an exercise/piece of practice you do with perpetrators, followed by some debriefing of this.

Keynote speech and 4 workshops

Day 3: Increasing Safety - there will be one workshop on examples of good practice and principles run by the WWP EN working group responsible for this work, the other 3 workshops are open for applications.

• 1 panel session on 'What does "victim-safety orientated programmes" mean in practice?' and 4 workshops

Timings:

Workshops = $1 \frac{1}{2}$ hours. Panels = a 10-15 minute talk then answering questions.

Numbers:

Workshops = up to 2 facilitators (3 if needed). Panels = up to 3 people per panel session.

Workshop guidelines:

Workshops should be interactive; they cannot only be presentations to participants. There may be some input/presentation element but we would like all workshops to also include:

• participation from attendees (e.g. small group work or experiential learning) and

include time for reflections and/or feedback from participants at the end.

If you would like to do this, but are worried about your level of English language, please let us know and we can help to find a speaker of fluent English to help you out. This is not a translator, but someone to help out with questions, small groupwork, etc.

WWP EN was lucky enough to have the 2017 Study Visit for members of the European Network for Work with Perpetrators in Sofia, Bulgaria. The visit was hosted by the Bulgarian Gender Research Foundation and its partners from the Alliance for Protection from Gender-based Violence, including NAIA Association- Targovishte (a new member of WWP EN).

These presented their methods and the locations of their work with perpetrators in Sofia, plus practices in the country. During the visit, meetings with other potential partners were organized and key institutions were visited, such as the court, police, and others. These visits were followed by in-depth group exchanges on laws and implementation of laws in the field of work with perpetrators. Our heartfelt thanks go to the people responsible for coordinating the visit, Genoveva Tisheva, Zlatka Macheva and Diyana Videva.

There were even rumours that the participants had a lot of fun as well!

Research from Women's Aid in England and the Cafcass (who support children and families in Family Courts) - shows that 62% of all the cases that go to the courts for decisions on where a child should live and spend time after parents have spit up feature allegations of domestic violence.

'What's The Crack', a new podcast that seeks to explore the research behind drug news stories, asked this week: What's the link between intimate partner violence and substance use? As one of the key questions that drives the ADVANCE PROGRAMME, the project team here at King's College London listened with intent. Speaking to Karen Baily, also a researcher at King's, and drawing on the work of Dr Gail Gilchrist, the podcast astutely 'discusses some of the myths, prevalence and patterns of behaviour that are associated with IPV as well as some of the issues facing those seeking treatment and help following an abusive relationship'.

Appearing first in the SAGE International Journal of Offender Therapy and Comparative Criminology, the research article "Evaluation of European Domestic Violence Perpetrator Programmes: Toward a Model for Designing and Reporting Evaluations Related to Perpetrator Treatment Interventions.", by Sarah-Jane Lilley, Marianne Hester and William Turner. This research builds on the Project Impact Research (see here for details - http://www.impact.work-with-perpetrators.eu/index.php?id=13) by taking that research and

adding to it studies and meta-analyses of European studies. The authors analyse 60 evaluaitns from 67 articles. This is a "must-read" if you are interested in evaluating your programme, using the Impact Toolkit (contact nina.george(at)work-with-perpetrators.eu if you are interested).

Usually, this is an article only available if you are signed up to the journal, but the authors have kindly agreed to let WWP EN members have sight of it on the internal area of your website.

Latest call for action grantson Prevetning and combatting gender-based violence and violance against children. Deadline 14th November 2017.

Priorities

- 1 Prevention of gender-based violence (GBV): The focus is on primary prevention, i.e. changing social attitudes and behaviour, in order to end tolerance of all forms of violence.
- 2 Protection and support for victims of gender-based violence and violence against children
- 3 The coordination and/or adaptation of support services for sexual and gender-based violence to include refugees and migrants (children, women, LGBTQI persons, young men and boys)
- 4 Treatment of perpetrators
- 5 National coordinating frameworks or action plans for violence against children (supporting Member States and other actors).
